## Client portals

Our client portals are built using HighQ Collaborate to create secure and highly customizable cloud-based platforms to work more collaboratively with clients. Our client portals are bilingual and offer file sharing, collaboration, project and task management solutions. They are accessible on the go, with mobile and tablet optimization.

### Features



**Files:** This module allows you to share documents with anyone you allow access to the platform. Sensitive documents can be protected with digital rights management allowing you to restrict saving and printing, and apply watermarks.



**iSheets:** This module allows you track data in a database similar to Excel with additional capabilities to allow you to view the data in different ways. You are also able to design a dynamic questionnaire, enabling you to populate the database with structured data to be later used for visualisations and document automation.



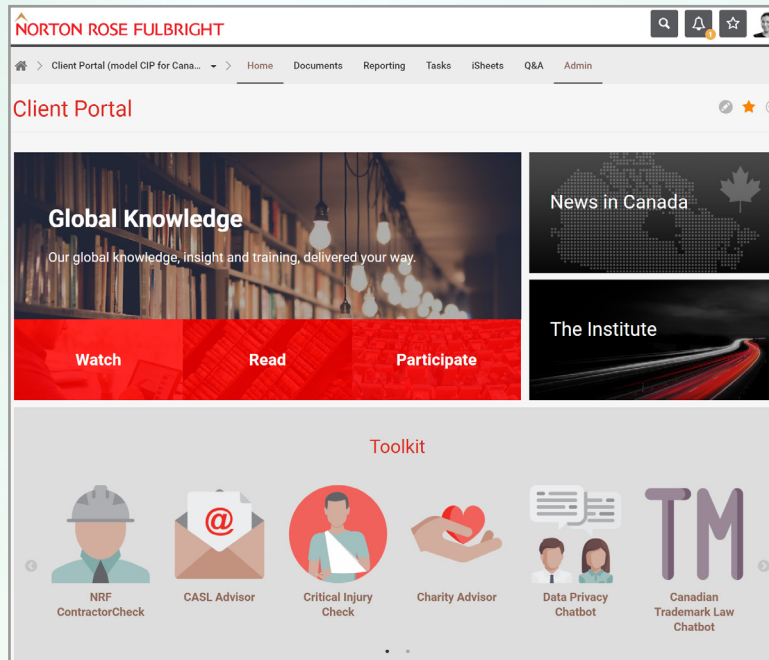
**Tasks:** The tasks module enables you to view the progress of projects, assign tasks to others, and add due dates, statuses, priorities, links, comments, and reminders all in the one place.



**Wiki:** This module allows you to post guidance and knowledge within the platform in a similar format to Wikipedia. Often this is used to guide members on aspects of the project.
