Session 1. Grid access | 18 March

Grid congestion poses a serious threat to energy projects, the energy-intensive industry, and other businesses. However, it also offers opportunities for new revenue models. Against this background, we will address in the first session of 2025 the main regulatory changes that recently took place in relation to grid access. We will explore the opportunities available to connected parties to obtain grid access in a flexible way during times of scarcity on the electricity grid. We will deep dive into the technical aspects of:

- Time based and time-block based transmission rights
- Cable pooling
- Capacitation limitation contract
- Redispatch

Session 2. Green hydrogen regulation | 15 April
